Section 18 Specific Exemption FOR DISTRIBUTION AND USE ONLY IN NORTH DAKOTA

This Specific Exemption is Valid from
August 1, 2006 to September 30, 2006.

All applicable directions, precautions, and restrictions on the EPA-approved label for Mustang Max (EPA Reg. No. 279-3249) must be followed.

THESE USE DIRECTIONS MUST BE IN THE POSSESSION OF THE USER AT THE TIME OF PESTICIDE APPLICATION.

The US Environmental Protection Agency has granted a specific exemption under the provisions of Section 18 of the Federal Insecticide, Fungicide and Rodenticide Act as amended, to the North Dakota Department of Agriculture for the use of Mustang Max Insecticide for grasshopper control in flax.

DIRECTIONS FOR USE:

Make applications when insect populations reach economic thresholds.

Refer to local Cooperative Extension Pest Management Guidelines and/or scouting results.

Apply by air or by ground equipment using sufficient water to obtain full coverage of foliage (minimum of 3 gallons per acre by air and 10 gallons per acre by ground).

Any adverse effects resulting from the use of Mustang Max under this emergency exemption must be immediately reported to the North Dakota Department of Agriculture.

RESTRICTIONS:

Do not apply more than 0.05 pounds active ingredient (8.0 fl oz of Mustang Max) per acre per season regardless of application method.

Do not apply within 30 days of harvest for flax seed.

ENVIRONMENTAL HAZARDS:

This pesticide is extremely toxic to fish and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment wash waters.

This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops if bees are visiting the treatment area.

CONDITIONS OF USE:
